- ▶ A non-athletic injury or sickness is not covered by the Sports Excellent Scholarship.
- ▶ The University will not take any secondary insurance coverage as such student should ensure they have their own personal insurance. This coverage is considered secondary to all other insurance coverage through the parents under which the student-athlete is covered.
- ▶ In the case of an athletic injury, the scholarship will still be intact as long as normal progression towards a degree occurs.
- ▶ If the length of time that is required for a student's degree exceeds the length of eligibility, sports scholarship will be discontinued and student has to be self-sponsored.

THE AGREEMENT

By my signature, I, _____, do hereby accept the terms of the Sports Excellent Scholarship listed above and acknowledge that:

- ▶ The Letter of Eligibility Requirements shall form as part of this agreement and be binding and enforceable against the parties.
- ▶ This agreement can be terminated and shall become null and void if:
 - i. I failed to abide by the rules, requirements, and the standards of the University and/or the lawful and reasonable instructions and/or directions of the University's Sports Unit Executive; or
 - ii. I get CGPA and GPA less than 2.5/have any disciplinary action against me/do not attend 80% of my class; or
 - iii. I do not take part to represent the University or take part in group training set by the University's Sports Unit Executive. Attendance will be taken and report submitted by Sports Unit Executive to the Bursary and financial; or
 - iv. I failed to meet the academic requirements or the admissions requirements of the University or this agreement is not signed and returned to the University by _____.
- ▶ If this agreement is terminated for any of the above reasons:
 - i. I will be held responsible for ALL fees and expenses incurred during the semester in which this agreement is terminated; Within 48 hours, I must make arrangements with the sports unit, financial assistance unit and student's bursary office for payment of my account;
 - ii. My responsibility will be to cover any University expenses not covered by this Sports Excellent Scholarship. I further understand that any expenses remaining unpaid due to incomplete financial aid applications or ineligibility will be due and payable at the time of registration per the policies of the University; and
 - iii. The University shall have the right to take any action(s) deemed necessary and permitted by law to protect and enforce its rights under the agreement in which I will also be liable for any costs and expenses incurred thereto.
- ▶ This agreement is governed by the laws of Malaysia.
- ▶ The stamping fee for 2 copies of this agreement shall be borne and paid by me.
- ▶ This agreement shall be binding upon the respective lawful assigns, heirs and successor-in-title of the parties.
